THIS CAUSE came on for consideration upon the Stipulation filed by the parties herein, and the Court having considered the matter together with the entire record and being otherwise fully advised in the premises, it is

ORDERED AND ADJUDGED that:

Judgment be, and the same is, hereby entered in favor of Plaintiff, SUNCOAST CREDIT UNION and against the Defendant(s), JERALD BYRD, 206 SE 5TH AVE, TRENTON FL 32693; last four of the SSN: [REDACTED] in the following sums:

(a) Principal balance due	\$5,014.26
(b) Interest accrued to date	\$728.86
(c) Court costs	\$371.00
(d) Attorney's fees	\$500.00

in the total sum of **\$6,614.12**, that shall hereafter bear interest at the prevailing statutory interest rate of 5.97% per year from this date through December 31 of this current year, for which let execution issue. Thereafter, on January 1 of each succeeding year until the judgment is paid, the interest rate will adjust in accordance with section 55.03, Florida Statutes.

Defendant(s) JERALD BYRD shall complete under oath Florida Rule of Civil Procedure Form 1.977 (Fact Information Sheet), including all required attachments, and serve it on Plaintiff's attorney at Wetherington Hamilton, P.A., 1010 N Florida Ave, Tampa FL 33602 within forty-five (45) days from the date of this Final Judgment, unless the Final Judgment is satisfied or post-judgment discovery is stayed. A copy of the Fact Information Sheet is attached to the Defendant(s)'s copy(ies) of the Final Judgment. Defendant(s) JERALD BYRD is not to file the original or a copy of the fact information sheet with the clerk in order to protect private information.

Jurisdiction of this case is retained to enter further orders that are proper to compel the defendant(s) JERALD BYRD to complete form, including issuance of an order for indirect contempt to issue an order of arrest should defendant, JERALD BYRD, fail to return the fact information sheet, and return it to the plaintiff's attorney, or the plaintiff, if the plaintiff is not represented by an attorney.
